CANINE COMPANIONS PLACED 378 WORKING DOGS IN 2020, DESPITE THE SETBACKS THE PANDEMIC BROUGHT TO OUR COMMUNITY. THROUGH DEDICATION AND INNOVATION, OUR IMPORTANT WORK CONTINUED. TRAINING THROUGH COVID-19 TRAINING STAFF TYPICALLY HAVE THEIR SCHEDULES DEDICATED TO IN-PERSON FOLLOW-UP VISITS WITH CLIENTS, TRAINING DOGS ON OUR CAMPUSES AND TEACHING NUMEROUS TEAM TRAINING CLASSES THROUGHOUT THE YEAR.
